On 01/02/2022 approximately 1400 hrs I was traveling in my PBSO issued marked green and white patrol vehicle (asset 75089) in the 4700 block of Fountains Drive in Lake Worth, when I observed the following series of event which was mostly captured by my in car video and audio recording device: I observed a black Toyota Corolla bearing Florida tag 65ABSS drive through a stop sign northbound in a careless manner at a rate of speed such that it was apparent this vehicle was not going to stop at the stop sign. I was afraid we were going to crash if I did not take evasive action, so I stopped my patrol vehicle in the intersection and the vehicle stopped as well, at this point the vehicle continued northbound and I activated my over headlights and initiated a traffic stop. It should be noted this vehicle also had a black license plate frame covering which obstructed the lettering in the word."FLORIDA". I approached the vehicle and immediately smelled the strong and obvious odor I recognized from my training and experience to be burnt marijuana. The vehicle was occupied four times: I identified the driver as Leonardo Sierra, front right passenger as Daleth Martinez, back right passenger as Joshua Gomez, and back left drivers Jonathan Nunez. I asked if anyone had their medical marijuana cards or any CBD products and no one said they did. I ordered the vehicle occupants out, searching each person. Martinez was wearing a purse around her waist, which contained over \$2,000 in cash wrapped in \$1,000 currency stacks. Martinez also had a black duffle bag on the floorboard in front of her that had the name "Daleth" inscribed on the top. Search of the vehicle revealed the following items: in the passenger door pocket next to Martinez was a clear bag containing a crushed green powdery substance (unidentified). In her duffle bag, there was a clear bag containing a red and white gummy candy that I recognized from my training and experience to be consistent with Edible THC/Synthetic Cannabinoid. In the back seat floorboards between where Nunez and Gomez were sitting was a food cannister. This cannister contained a wallet with Martinez' two Florida Identification/ Driver's license cards, along with a credit card in her name. Also in this container were the following items: A green cannister containing two clear bags of twenty-six (26) white oxycodone 10mg pills, a zipper bag containing five (5) blue Oxycodone 30mg "M30" oxycodone pills and \$70 in cash, a clear bag with five multi-color pills that field tested positive for Amphetamines, a clear bag with thirty-two (32) pink rectangle pills inscribed "RR Rolls Royce" which field tested positive for Aaphetamines, a large bag of leafy green marijuana, two digital scales, and a prescription pill bottle containing two 5mg Oxycodone pills. The total combined weight of all of the Oxycodone pills was around 14.3 grams.

It should be noted that a loaded stolen handgun was located in a bag in the seat directly behind

Based on the above facts and circumstances, probable cause exists to charge Daleth Martinez with: Possession of Drug Paraphernalia pursuant to FSS 893.147(1), Trafficking Oxycodone pursuant to FSS 893.136(1)(c)(3)(b), Possession of Edible THC/Synthetic Cannabinoid pursuant to FSS 893.13(6)(a), and with possession of Amphetamines pursuant to FSS 893.13(6)(a).
