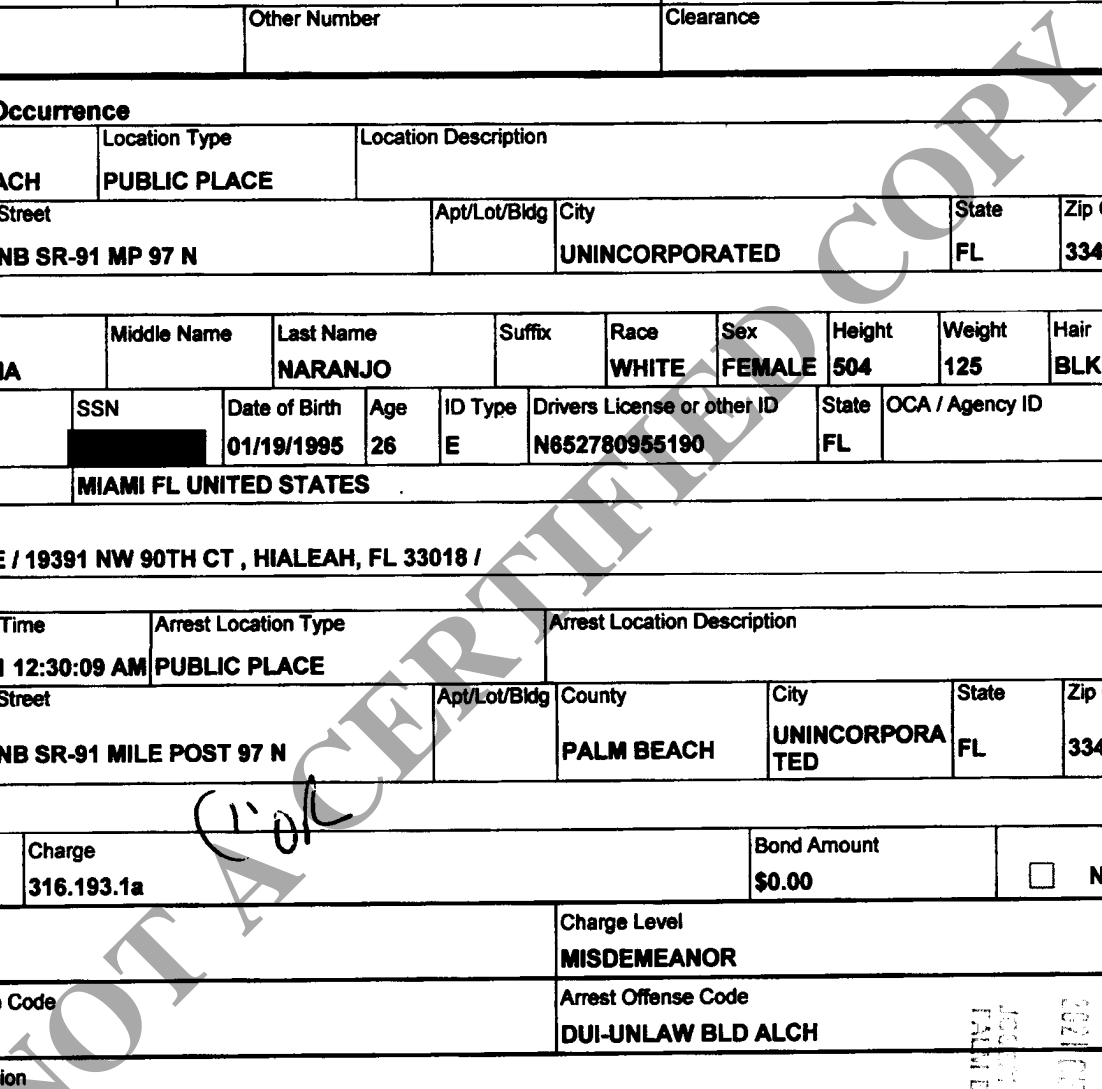

On the above date and time, I, Trooper Specialist J. Lampiasi ID 1649, and Trooper A. Rovirosa ID 1900, were traveling north on SR-91, Florida's Turnpike, around mile post 97 in Palm Beach County, Florida. I observed a white SUV bearing FL Tag 95APEI traveling at a slow rate of speed within the right outside lane. A vehicle that was traveling directly behind the white SUV needed to brake suddenly in order to avoid colliding with the rear. At that time, due to the vehicle's driving behavior, I conducted a traffic stop on the vehicle. I also wanted to check the welfare of the driver as this was not normal driving behavior.

The vehicle initially completely stopped within the entrance acceleration ramp to the turnpike. Tpr. Rovirosa advised over the PA system to pull over to the right shoulder. Once the vehicle was stopped, we approached the driver's side window. We identified the driver via her FL DL as Samantha Naranjo. I immediately smelled the odor of an alcoholic beverage emitting from within the vehicle. Ms. Naranjo's eyes were watery/glassy. Tpr. Rovirosa asked Ms. Naranjo why she was driving so slow which she indicated that she was fine. Ms. Naranjo's speech was slurred and thick. I smelled the odor of an alcoholic beverage emitting from Ms. Naranjo's breath as she spoke. Ms. Naranjo stated that she was heading to "Kendall" in Miami even though she was heading northbound on the turnpike away from Miami.

We asked Ms. Naranjo to exit the vehicle at this time. As Ms. Naranjo exited the vehicle, she appeared to be unsteady. Ms. Naranjo needed to lean up against the patrol vehicle at one point. Ms. Naranjo appeared to be swaying visibly. I asked Ms. Naranjo if she would like to participate in Standardized Field Sobriety Tasks (SFST's). Ms. Naranjo denied. I advised Ms. Naranjo that if she failed to participate, I would have to judge my further decisions based on the information that I have already seen/gathered. Ms. Naranjo denied again. Due to the totality of the circumstances regarding Ms. Naranjo's driving behavior and person interaction, I concluded that her normal faculties were impaired at the time she operated her motor vehicle. Ms. Naranjo was arrested for Driving Under the Influence at 0030 hours. Ms. Naranjo was handcuffed (double locked) and placed in the rear of my patrol vehicle. Ms. Naranjo was asked to provide a sample of her breath at 0059 hours as I have a mobile Intoxilyzer 8000 installed in the rear seat of my vehicle.
